

PARTICIPANT'S RELEASE FORM AND INDEMNITY AGREEMENT

PLEASE READ CAREFULLY BEFORE SIGNING.

I, _____, the undersigned agree:

That I will fully participate in this retreat/workshop in which I am registered. I understand that I am participating at my own risk.

That I am physically able to do such retreat/workshop or program and that I have no medical problems which may be affected by these activities and any other activity at the retreat/workshop/program, such as dance, movement, breath, hiking, energy work, etc. I agree to monitor my participation and not exceed my own limits and I assume all risk for my condition in this retreat/workshop. I acknowledge that I assume all risk from any consequences due to any pre-existing physical or psychological conditions that I have.
